FRESHMAN 2018 – 2019 TUITION INVESTMENT CONTRACT

The following items are due on **Saturday, March 3, 2018**.

- ❖ This CONTRACT completed, signed, and dated; ONE per family.
- ❖ *A non-refundable REGISTRATION FEE of \$200.*
 - Technology Fee is included.
 - Students will be scheduled for classes once we receive the contract with the Registration Fee.

FINANCIAL OBLIGATIONS

1. DISCOUNT

- Each student will receive a \$100 *Our Lady of Grace* discount on his/her 2018-2019 tuition.

2. FUNDRAISING

- EACH STUDENT is required to sell eight (8) raffle calendars @ \$25 per calendar totaling \$200. This is the only MANDATORY, all-school student fundraiser; if unsold, \$200 will be added to the student's tuition account.

3. MISCELLANEOUS

- In order to reserve a student's place at EC and have him/her scheduled for classes for the 2018-2019 school year, the non-refundable \$200 Registration Fee is required by Saturday March 3, 2018.
- In order for a student to receive his/her class schedule in early August and any school-sponsored tuition assistance for the 2018-2019 school year, tuition payments must be current through July 15, 2018.
- Students who withdraw during the first semester are obligated for tuition payment for half the yearly tuition cost *through December 20, 2018*. Students who withdraw during the second semester are obligated to pay full year tuition cost through *April 15, 2019*.
- ALL STUDENTS: Report cards, transcripts, and Progress Book access will be withheld for non-payment of debts owed to the school.
